20 PURPOSE OF SUPPLEMENTAL DECISION

21 On July 24, 1995, the Board entered its decision in the
22 above-captioned Case (Item No. 358), which, in pertinent part,
23 ordered Respondent to pay the reasonable cost and attorney's
24 fees incurred by the Complainants in processing the Complaint
25 before the Board. The Decision and Order instructed the
26 Complainants to submit a statement of costs and attorney's
27 fees for the Board's consideration and deliberation, in order
28 that it (the Board) could determine the monetary award which
it regarded as "reasonable costs and attorney's fees".

1 Before the Board had an opportunity to consider the
2 Complainants' statement of costs and attorney's fees (as well
3 as Respondent's opposition thereto) and determine the amount
4 to award as "reasonable costs and attorney's fees" in the
5 instant Case, the Respondent filed a Petition for Judicial
6 Review of the Board's Decision in District Court, which
7 effectively removed the Case from the Board's jurisdiction.

8 On September 28, 1995, the Board received a Stipulation
9 (signed by counsel for the parties and the Board) and Order
10 (signed by District Court Judge Jack Lehman), remanding the
11 issue of attorney's fees and costs back to the Board for
12 decision.

13 On October 11, 1995, the Board conducted a special
14 telephonic meeting, noticed pursuant to Nevada's Open Meeting
15 Law, to determine the amount to be awarded as "reasonable
16 costs and attorney's fees" in the instant Case.

17 SUPPLEMENTAL DECISION AND ORDER

18 After due consideration of all the evidence and argument
19 of record with respect to the issue of costs and attorney's
20 fees, and pursuant to the Board's deliberations at its October
21 11, 1995 meeting,

22 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that


