14 On July 21, 1997, the Board entered its decision in the above-captioned Case (Item No. 383-  
15 E), which, in pertinent part, ordered Respondent to pay the reasonable costs and attorney's fees  
16 incurred by the Complainants in processing the Complaint before the Board. The Decision and Order  
17 instructed the Complainants to submit to the Board an affidavit for reimbursement of attorney's fees  
18 and costs and reimbursement of back pay for employees ordered reinstated, David Burress and  
19 Leonard Griffin. On December 30, 1997, Complainant filed its Motion for Back Pay and a Motion  
20 for Attorney's Fees and Costs.

21 Oral argument was entertained by the Board at its meeting of February 12, 1998, noticed  
22 pursuant to Nevada's Open Meeting Law. Pursuant to the Board's deliberations on said issues,

23 IT IS HEREBY ORDERED, ADJUDGED AND DECREED, that the Respondent shall pay  
24 reasonable attorney's fees and costs in the amount of forty-one thousand, nine hundred and seventy  
25 seven dollars (\$41,977.00).

1 IT IS FURTHER ORDERED, that the Respondent shall pay reimbursement of back pay for  
2 Griffin in the amount of thirty-one thousand, six hundred and eighty dollars (\$31,680.00), which  
3 represents pay for 508 days of lost earnings at his average daily wage of \$114.61 deducting for  
4 interim earnings of \$26,541.00, and for Burress in the amount of forty-six thousand, nine hundred  
5 and sixty-seven dollars (\$46,967.00), which represents 391 days of lost earnings at his daily wage of  
6 \$120.12. These amounts do not include mileage reimbursement as this Board does not consider  
7 mileage reimbursement as wages.
