17 On April 11, 2001, Complainant POLICE MANAGERS AND SUPERVISORS  
18 ASSOCIATION, INC., (hereafter "PMSA") filed a Complaint with the Local Government

27 good cause appearing,




1 IT IS HEREBY ORDERED that the Petition to Intervene is granted.


2 IT IS FURTHER ORDERED that Metro shall file an answer or other responsive pleading
