18 On July 6, 2001, Complainants DOUGLAS WAYNE SLAG AND HERMOGENA
19 CANETE SLAG (hereafter "Complainants") filed a verified complaint with the LOCAL
20 GOVERNMENT EMPLOYEE-MANAGEMENT RELATIONS BOARD (hereafter "Board").

21 The CLARK COUNTY SCHOOL DISTRICT (hereafter "District") filed a Motion to
22 Dismiss and on November 16, 2001, the Board issued an order denying, among other things, the
23 District's motion to dismiss.

24 On December 26, 2001, attorney William Louis Messenger filed an application for
25 admission *pro hac vice, nunc pro tunc*, and for association of counsel. No opposition has been
26 received.

27 On January 29, 2002, the District filed a request to review motion to dismiss.


1 The Board deliberated on said request for review and application on February 12, 2002,

3 cause appearing,


4 IT IS HEREBY ORDERED that the application for pro hac vice and for permission to

7 for Complainants herein and may continue to represent these parties before the Board in this
8 matter.


9 IT IS FURTHER ORDERED that after further review, the Board reaffirmed its previous
