15 On March 31, 2004, the LOCAL GOVERNMENT EMPLOYEE-MANAGEMENT  
16 RELATIONS BOARD (hereafter "Board") issued an order (Item #573) denying the various  
17 motions pending before the Board and ordered the Respondents CLARK COUNTY SCHOOL  
18 DISTRICT and EDWARD GOLDMAN (hereafter "District") to answer the complaint and  
19 ordered the Complainant EDUCATION SUPPORT EMPLOYEES ASSOCIATION (hereafter  
20 "Association") to brief the issue of whether this Board has jurisdiction over Business Benefits,  
21 Inc.

22 On April 19, 2004, the District filed their Answer and on the same day the Association  
23 filed a Motion for Temporary Stay. As of the date of this order, no opposition has been received.

24 The Board deliberated on said motion on June 1, 2004, noticed in accordance with  
25 Nevada's Open Meeting Laws. Based upon the deliberations,

26 IT IS HEREBY ORDERED that the unopposed Motion for Temporary Stay is granted  
27 for forty-five (45) days [NAC 288.240 (6)]. Upon the conclusion of the 45 days, the parties shall


1 file either a Stipulation to Dismiss or the parties will file their pre-hearing statements and briefs


