16 On January 13, 2004, Complainant LAS VEGAS POLICE PROTECTIVE
17 ASSOCIATION METRO, INC. and POLICE OFFICER JOHN MEDLICOTT ("Association")
18 filed a complaint with the LOCAL GOVERNMENT EMPLOYEE-MANAGEMENT
19 RELATIONS BOARD ("Board").

20 On August 2, 2005, Respondent LAS VEGAS METROPOLITAN POLICE
21 DEPARTMENT ("Metro") filed a Motion for Summary Judgment and on August 9, 2005, Metro
22 further filed a Motion for Leave to Exceed Thirty Page Limit.

23 On August 31, 2005, the Association filed its opposition and on September 27, 2005,
24 Metro filed their reply.

25 The Board held deliberations on said motion on October 10, 2005, noticed in accordance
26 with Nevada's Open Meeting Law. Based upon the Board's deliberations,

27 IT IS HEREBY ORDERED that Respondent's Motion for Leave to Exceed Thirty Page
28 Limit For Respondent's Motion for Summary Judgment is Granted.
