16 On May 5, 2004, Complainant MIKE RENNIE ("Rennie") filed a Complaint with the  
17 LOCAL GOVERNMENT EMPLOYEE-MANAGEMENT RELATIONS BOARD ("Board").  
18 On October 13, 2004, he filed his First Amended Complaint. On February 23, 2005, the Board,  
19 upon the Motion to Dismiss filed by Respondent COUNTY OF NYE, and joined by Respondent  
20 NYE COUNTY LAW ENFORCEMENT ASSOCIATION, entered its Order dismissing Rennie's  
21 Complaint with prejudice. On March 23, 2005, the Board received Rennie's "Notice of Appeal"  
22 stating "I GIVE NOTICE OF APPEAL for case number A1-045799 on the order rendered on  
23 February 23, 2005."

24 On April 20, 2005, the Board held deliberations on the "Notice of Appeal," noticed in  
25 accordance with Nevada's Open Meeting Laws. Based upon the Board's deliberations, the Board  
26 hereby

27 ORDERS that because NRS Chapter 288 provides no mechanism by which to "appeal" to  
28 the Board from its own final decision, cf. NRS 233B.130(6) ("The provisions of [NRS Chapter


1 233B] are the exclusive means of judicial review of, or judicial action concerning, a final  
2 decision in a contested case involving an agency to which [NRS Chapter 233B] applies."), the  
3 Board will not consider Rennie's submitted "Notice of Appeal."


