
15 On or about July 12, 2004, a complaint was filed with the Local Government Employee-  
16 Management Relations Board ("Board") by Complainant, Elko County Deputy Sheriff's  
17 Association ("Association"). An answer was filed by the Elko County Sheriff's Office and Elko  
18 County (collectively "Elko County") on or about August 4, 2004. Thereafter, Elko County filed  
19 a motion to dismiss this matter. An opposition was filed by the Complainant, and the  
20 Respondents filed their reply points and authorities. On or about September 22, 2004, this Board  
21 entered its order deferring this matter for exhaustion of the parties' contractual grievance  
22 remedies. The Board further ordered that the parties provide a written status report within six  
23 months from the order and provide a report to the Board within thirty (30) days after completion  
24 of the grievance process. To date, neither the initial status report nor the subsequent report has  
25 been filed with the Board by either party.

26 This matter was noticed for deliberations by the Board on the 13<sup>th</sup> day of March, 2007,  
27 pursuant to the provisions of NRS and NAC Chapters 288, as well as NRS Chapter 233B and  
28 Nevada's Open Meeting laws.


1 IT IS HEREBY ORDERED that the parties shall have to and including the 1st day of  
2 April, 2007, within which to provide this Board with a status report. Should the parties fail to do  
3 so, this matter will be dismissed pursuant to NAC 288.373. Additionally, this matter may be
