17 On August 12, 2004, Complainant LYON COUNTY EDUCATION ASSOCIATION
18 (hereafter "Association") filed a Complainant with the LOCAL GOVERNMENT EMPLOYEE-
19 MANAGEMENT RELATIONS BOARD (hereafter "Board").

20 On September 7, 2004, Respondent LYON COUNTY SCHOOL DISTRICT; NATALE
21 LOMMORI and MELINDA JOHNSON (hereafter "District") filed a Motion to Dismiss. The
22 Association filed an opposition on September 23, 2004 and the District filed their reply on
23 October 1, 2004.

24 The Board held deliberations on said motion on November 3 and 4, 2004 and January 5,
25 2005, noticed in accordance with Nevada's Open Meeting Law. Based upon the Board's
26 deliberations,

27 IT IS HEREBY ORDERED that Respondent's Motion to Dismiss the Complaint and its
28 included request for costs and fees are DENIED.

4 exhaustion of the parties' contractual grievance arbitration remedies.


5 IT IS FURTHER ORDERED that the parties are to provide a written status report to the
