16 On August 12, 2004, Complainant LYON COUNTY EDUCATION ASSOCIATION
17 (hereafter "Association") filed a Complaint with the LOCAL GOVERNMENT EMPLOYEE-
18 MANAGEMENT RELATIONS BOARD (hereafter "Board") against Respondent LYON
19 COUNTY SCHOOL DISTRICT; NATALE LOMMORI and MELINDA JOHNSON (hereafter
20 "District").

21 On February 23, 2005, the Board entered an order denying the District's Motion to
22 Dismiss and further deferred the matter for exhaustion of the parties' contractual remedies.

23 On March 29, 2005, the Association filed a Report of Arbitrator's Opinion and Award;
24 Motion for Complaint to be Scheduled for Hearing. The District filed a Renewal of Motion to
25 Dismiss on April 11, 2005. The Association opposed the motion on May 4, 2005 and the District
26 filed its reply on May 11, 2005.

27 The Board held deliberations on said motion on July 21, 2005, noticed in accordance with
28 Nevada's Open Meeting Law. Based upon the Board's deliberations,

IT IS HEREBY ORDERED that Respondent's Motion to Dismiss is denied;

1 IT IS FURTHER ORDERED that Complainant's Motion for Complaint to be Scheduled
2 for Hearing is denied without prejudice; and

3 IT IS FURTHER ORDERED that, pursuant to NAC 288.220, Respondent shall file its
4 Answer to the above-captioned Complaint within twenty (20) days from the date of Entry of this
5 Order, the hearing on the Complaint to be scheduled after the parties file their Pre-hearing
6 Statements, pursuant to NAC 288.250.
