15 On August 4, 2004, the DOUGLAS COUNTY PROFESSIONAL EDUCATION
16 ASSOCIATION ("Association") filed with the LOCAL GOVERNMENT EMPLOYEE-
17 MANAGEMENT RELATIONS BOARD ("Board") a Complaint against DOUGLAS COUNTY
18 SCHOOL DISTRICT ("District"). The District filed a Motion to Dismiss and Motion for
19 Attorney's Fees and Costs. The Association filed an opposition and the District filed its reply.

20 On February 23, 2005, the Board entered an order denying the District's Motion to
21 Dismiss and Motion for Attorney's Fees and Costs. The Board further ordered the District file
22 its answer within twenty (20) days.

23 On March 18, 2005, the Association and the District signed and filed a Stipulation for
24 Stay of Proceedings Pending Recommendation of NRS 391 Hearing Officer.

25 On March 30, 2005, the Board held deliberations on the Stipulation, noticed in
26 accordance with Nevada's Open Meeting Law. Pursuant to these deliberations,

27 IT IS HEREBY ORDERED that this matter is stayed until after the Hearing Officer's
28 Report and Recommendation is issued.

1 IT IS FURTHER ORDERED that barring further stipulation by the parties, the District
2 shall file an answer to the complaint within twenty (20) days after the Report and
3 Recommendation is received by the parties.
