15 On January 26, 2005, Complainant INTERNATIONAL ASSOCIATION OF  
16 FIREFIGHTERS, LOCAL #1607 ("Association") filed a complaint with the LOCAL  
17 GOVERNMENT EMPLOYEE-MANAGEMENT RELATIONS BOARD ("Board") against  
18 Respondent CITY OF NORTH LAS VEGAS ("City").

19 On February 17, 2005, the City filed its Answer and on February 25, 2005, the  
20 Association filed a Motion to Amend and Supplement the Complaint. The Association filed its  
21 Pre-Hearing Statement and a Supplement to its Motion to Amend and Supplement the Complaint  
22 on March 4, 2005. Correspondence was received on March 15, 2005, from the City stating it did  
23 not oppose the Association's Motion to Amend.

24 On March 30, 2005, the Board held deliberations on the motion, noticed in accordance  
25 with Nevada's Open Meeting Law. Based upon the Board's deliberations,

26 IT IS HEREBY ORDERED that the Association's Motion to Amend and Supplement the  
27 Complaint as well as its Supplement to the motion is granted. The Association shall file its  
28 Amended Complaint within twenty (20) days from the date of this order.

1 IT IS FURTHER ORDERED that the City shall file an Answer to the Amended  
2 Complaint within twenty (20) days after receipt of the Amended Complaint. Thereafter, both the  
3 Association and the City shall file Prehearing Statements in accordance with NAC 288.250.
