16 On April 4, 2006, the LOCAL GOVERNMENT EMPLOYEE-MANAGEMENT
17 RELATIONS BOARD ("Board") issued an order finding in favor of Respondents ELKO
18 COUNTY SCHOOL DISTRICT and ELKO COUNTY BOARD OF SCHOOL TRUSTEES
19 ("District"). In its order, the Board awarded the District reasonable fees and costs and ordered
20 the District to submit its documents and records in support of its request.

21 On April 12, 2006, the District filed its Request for Attorneys Fees and Costs. On April
22 26, 2006, Complainant ELKO COUNTY CLASSROOM TEACHERS ASSOCIATION
23 ("Association") filed an opposition and on May 1, 2006, the District filed its reply.

24 On April 17, 2006, the Association filed a Motion for Rehearing and Modification of
25 Order. The District filed a Motion to Strike Portions of Complainant's Motion for Rehearing and
26 Modification of Order on April 26, 2006.


27 The Board held deliberations on the District's request and on the Association's Motion
28 on May 2, 2006, noticed in accordance with Nevada's Open Meeting Law. Based upon the
Board's deliberations,

1 IT IS HEREBY ORDERED that the Motion for Rehearing and Modification of Order is
2 denied.

3 IT IF FURTHER ORDERED that the District shall be awarded \$10,444.30 for attorney's
4 fees and costs.
