20 Clark County Health District ("CCHD") is the Complainant in A1-045826 and the
21 Respondent in the balance of the above-captioned matters. Service Employees International
22 Union, Local # 1107 ("SEIU") is Respondent in A1-045826 and Complainant in the balance of
23 the above-captioned actions.

24 CCHD has made a motion to consolidate the above-captioned matters into one
25 proceeding. SEIU has responded that the matters should be consolidated in to smaller groups,
26 with some of the matters to remain unconsolidated.

27 The Board held deliberations in this matter on September 7, 2005, in accordance with
28 Nevada's Open Meeting Law, and based thereon,

1 The Board finds that the matters involve issues that are substantially the same, in that
2 they relate to refusal to bargain in good faith and grow out of events related to failure of said
3 negotiations, that neither of the parties would be prejudiced by consolidation, and that all of the
4 matters should be consolidated pursuant to NAC 288.275(1).

5 IT IS ORDERED that the above-captioned matters be consolidated.

6 IT IS FURTHER ORDERED that each party should file a single consolidated Pre-
7 hearing Statement within thirty (30) days of this order.
