16 On November 30, 2005, Petitioner UNITED WE STAND CLASSIFIED EMPLOYEES –
17 AFT (“UWSCE”) filed a Petition Challenging Recognition of Employee Organization and
18 Petition for Election of Representative with the LOCAL GOVERNMENT EMPLOYEE-
19 MANAGEMENT RELATIONS BOARD (“Board”).

20 On December 19, 2005, Respondent WASHOE COUNTY SCHOOL DISTRICT
21 (“District”) filed an answer to the petition.

22 On December 23, 2005, Respondent WASHOE EDUCATION SUPPORT
23 PROFESSIONALS (“WESP”) filed a Motion to Dismiss or, in the Alternative, to Strike.
24 UWSCE filed its opposition on January 3, 2006 and WESP filed their reply on January 12, 2006.

25 The Board held deliberations on said motion on March 21, 2006, noticed in accordance
26 with Nevada’s Open Meeting Law. Based upon the Board’s deliberations,


1 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Respondent's Motion
