13 On January 24, 2006, Complainant BRADLEY WALKER, M.D. ("Walker") filed a
14 Complaint with the LOCAL GOVERNMENT EMPLOYEE-MANAGEMENT RELATIONS
15 BOARD ("Board").

16 On March 20, 2006, Respondent UNIVERSITY MEDICAL CENTER OF SOUTHERN
17 NEVADA ("UMC") filed its Answer and a Motion to Dismiss Claims. On April 3, 2006,
18 Walker filed his opposition and UMC filed their reply on April 17, 2006.

19 On April 12, 2006, Walker filed his Pre-Hearing Statement and UMC filed its Pre-
20 Hearing Statement on April 21, 2006.

21 The Board held deliberations on UMC's Motion to Dismiss at their scheduled meeting on
22 May 2, 2006, which was noticed in accordance with Nevada's Open Meeting Law. Based upon
23 the Board's deliberations,

24 IT IS HEREBY ORDERED that the Motion to Dismiss is granted in part and denied in
25 part as follows:

26 The Board GRANTS UMC's Motion to Dismiss as to Walker's claims for punitive
27 damages, Intentional Infliction of Emotional Distress, his claims arising under the Federal
28 Family and Medical Leave Act, claims relating to alleged violations of Title VII of the Civil


1 Rights Act, and claims relating to alleged retaliation against Walker for union activities and/or
2 for prior testimony given by Walker relating to an alleged Equal Employment Opportunity
3 Commission charge, as these claims do not properly fall within the Board's jurisdiction.


4 The Board DENIES UMC's Motion to Dismiss as to any claims made by Walker which
5 relate to alleged refusals to bargain in violation of the provisions of NRS Chapter 288.


6 IT IS FURTHER ORDERED that the parties shall file amended pre-hearing statements
