17 On November 18, 2008, this matter came on before the Local Government Employee-
18 Management Relations Board ("Board") for discussion and deliberations concerning the
19 "Stipulation for Dismissal with Prejudice" ("Stipulation") filed by the law firm of Olson,
20 Cannon, Gormley & Desruisseaux on behalf of the North Las Vegas Police Officers Association
21 ("Association") and Complainant Eric Spannbaauer ("Spannbauer"). This matter was noticed
22 pursuant to NRS and NAC chapters 288, as well as Nevada's Open Meeting Laws and NRS
23 chapter 233B.

24 It should be noted that the Stipulation was filed with the Board on October 2, 2008. On
25 October 2, 2008, this Board rendered its "Final Findings of Fact, Conclusions of Law and Order"
26 and administratively noticed that the Stipulation had been filed. The Board further noted that
27 pursuant to "Nevada's open meeting laws, this stipulation cannot be addressed at this time [as it

1 was not placed on the Board's agenda for consideration]. As is typical and appropriate, the
2 Board's staff will place the stipulation on the Board's next agenda for action, if any."

3 A review of the file also indicates that the law firm of Laquer, Urban, Clifford & Hodge
4 is the law firm/attorneys of record for the Association. No substitution of attorneys have been
5 filed replacing that firm with the firm of Olson, Cannon, Gormley & Desruisseaux.


6 In any event, since a final decision has been rendered in this matter, and the matter is also
7 currently under judicial review by the Eighth Judicial District Court, this Board no longer has
8 jurisdiction to grant a dismissal based upon the Stipulation. Should this matter be remanded by
9 the Eighth Judicial District Court to this Board, this document will then be addressed and an
10 appropriate order entered.
