15 This matter came on for discussion and deliberations by the Local Government
16 Employee-Management Relations Board ("Board") on the 30th day of May, 2007, noticed
17 pursuant to NRS and NAC chapters 288, NRS chapter 233B, and Nevada's open meeting laws.
18 The Board finds, concludes, and orders as follows:


19 The Board entered its decision in this matter on March 13, 2007, finding in favor of
20 Farsaci. The Board awarded attorney's fees and costs to Farsaci and directed that a motion for
21 the same be filed. The motion was filed on March 29, 2007. It was opposed by the Service
22 Employees International Union, Local 1107 ("Union") on April 12, 2007. Reply points and
23 authorities were filed by Farsaci on April 18, 2007.


24 Having thoroughly reviewed the billings of Farsaci, the Board is not awarding fees for
25 secretaries' time or paralegal's time. The Board is also not awarding any costs to Farsaci for
26 finance charges. Such may be required by any employment contract entered into by Farsaci and
27 his attorneys, however, the Board is exercising its discretion not to award reimbursement for the
28 same.

1 THEREFORE, IT IS HEREBY ORDERED that Farsaci is hereby awarded the sum of
2 \$28,550.00 as attorneys' fees and the amount of \$5,000.00 as costs. The Board's decision of
3 March 13, 2007, also ordered that any such award would be adjusted due to Farsaci's failure to
4 mitigate his losses; and the Board is exercising its discretion to reduce the attorneys' fees award
5 by fifteen percent (15%), i.e., the award of attorneys' fees is thus reduced to \$24,267.00. The
6 award of costs remains in the amount of \$5,000.00.
