19 On or about November 3, 2006, CAROLINE RANGEN, RON SUFANA, JR., PERAL
20 MORRIS, SANDRA-LEE A. PUGLIA, LILIA CASTRO, MICHAEL S. HAMPTON,
21 MICHAEL POWELL, KARL ESPARZA, ANA L. INZUNZA, MARI FERNANDEZ, JANET

23 filed a prohibited labor complaint against the EDUCATION SUPPORT EMPLOYEES

25 fair representation.


26 On November 29, 2006, the Association filed a Motion to Dismiss. Thereafter, the
27 Complainant's filed an Opposition, and the Association filed its Reply authorities with affidavits.

1 This matter came on before the LOCAL GOVERNMENT EMPLOYEE-
2 MANAGEMENT RELATIONS BOARD ("Board") on January 17, 2007, for deliberations
3 pursuant to NRS and NAC Chapters 288, as well as Nevada's Open Meeting laws, and good
4 cause appearing therefore,


5 IT IS HEREBY ORDERED that the Motion is denied and this matter shall proceed. This
6 denial is based on the appearance at this time of a violation of the Association's duty of fair
7 representation, rather than a breach of contract. On that basis alone, the motion is denied. An


