**ORDER**

14 This matter came on for discussion and deliberations by the Local Government  
15 Employee-Management Relations Board ("Board") on the 30<sup>th</sup> day of May, 2007, noticed  
16 pursuant to NRS and NAC chapters 288, NRS chapter 233B, and Nevada's open meeting laws.  
17 The Board finds, concludes, and orders as follows:


18 The Clark County Education Association ("Association") filed a "Motion to Strike  
19 Complainant's Motion to Dismiss Counterclaim" on May 3, 2007. Ronald G. Taylor ("Taylor")  
20 filed an opposition on May 11, 2007. The Association filed its reply points and authorities on  
21 May 29, 2007. The Motion to Strike was based on Taylor's signing the certificate of mailing on  
22 April 18, 2007, indicating that the document was mailed on that date; however, the document  
23 was file-stamped on April 20, 2007, and the envelope is postmarked April 21, 2007.


24 Based upon the documents filed to date, and good cause appearing therefor, IT IS  
25 HEREBY ORDERED that the "Motion to Strike Complainant's Motion to Dismiss  
26 Counterclaim" is denied as no prejudice has resulted from the erroneous information contained  
27 within the certificate of mailing and the pro se complainant hopefully has now had a lesson on  
28 the procedures of filing and serving documents pursuant to NRS and NAC chapters 288.

1 IT IS FURTHER ORDERED that the Association shall file an opposition to the Motion  
2 to Dismiss Counterclaim within ten (10) days of service of the order. The Motion to Dismiss  
3 Counterclaim was filed by Taylor on April 20, 2007.
