15 On March 2, 2007, a document entitled "Motion to Produce Memorandums of
16 Understanding and Any Related Negotiated Agreements" was filed with the Local Government
17 Employee-Management Relations Board ("Board") by Complainant, Ronald G. Taylor. A copy
18 of said "Motion" was mailed to each of the Respondents. To date, a pleading entitled
19 "Complaint" has not been filed in this matter. Correspondence was received from each of the
20 Respondents claiming that the "Motion" is a fugitive document, and that it should be stricken.

21 This matter was noticed for deliberations by the Board on the 1st and 2nd day of May,
22 2007, pursuant to the provisions of NRS and NAC Chapter 288, as well as NRS Chapter 233B
23 and Nevada's Open Meeting laws.

24 Pursuant to NRS 288.110(2), this Board may hear "any complaint" filed with it "arising
25 out of the interpretation of, or performance under, the provisions of this chapter. . . ." NAC
26 288.200 specifies the requirements of a "complaint" filed with the Board. The document entitled
27 "Motion" does not meet the requirements of NAC 288.200.



3 not a "complaint," and that answers from the Respondents are not required.


4 IT IS FURTHER ORDERED that this matter bearing Case No. A1-045907 shall be
