16 On the 23rd day of June, 2008, this matter came on before the State of Nevada, Local  
17 Government Employee-Management Relations Board ("Board"), for consideration and decision  
18 pursuant to the provisions of NRS and NAC chapters 288, NRS chapter 233B, and Nevada's  
19 open meeting laws.

21 A complaint was filed in this matter on January 24, 2008 by Complainant Nicole Wilson  
22 ("Wilson"), in proper person. On February 19, 2008, the North Las Vegas Police Department  
23 ("Police Department") filed its answer. On that same date, the North Las Vegas Police Officers  
24 Association ("Association") filed an answer and a motion to dismiss based upon an alleged  
25 failure by Wilson to state a proper cause of action. The Board treated the motion as one  
26 requesting a more definite statement: and, on May 6, 2008, Wilson filed an amended complaint.  
27 The amended complaint was served on the City of North Las Vegas and its Police Department.  
28 Thereafter, the Police Department did not file an answer to the amended complaint.


On May 23, 2008, Wilson filed a notice requesting the dismissal of the Association.


1 Based upon Wilson's request, IT IS HEREBY ORDERED that the Association is hereby  
2 dismissed from this matter, with prejudice, with each party to bear their own attorneys' fees and  
3 costs. The caption shall henceforth be modified to reflect the deletion of the Association as a  
4 Respondent.


5 IT IS FURTHER ORDERED that Wilson and the Police Department shall file their
