15 On the 10th day of September, 2008, this matter came on before the State of Nevada,  
16 Local Government Employee-Management Relations Board ("Board"), for consideration and  
17 decision pursuant to the provisions of NRS and NAC chapters 288, NRS chapter 233B, and  
18 Nevada's open meeting laws.

19 A complaint was filed in this matter on January 24, 2008 by Complainant Nicole Wilson  
20 ("Wilson"). in proper person. On February 19, 2008, the North Las Vegas Police Department  
21 ("Police Department") filed its answer. On that same date, the North Las Vegas Police Officers  
22 Association ("Association") filed an answer and a motion to dismiss based upon an alleged  
23 failure by Wilson to state a proper cause of action. The Board treated the motion as one  
24 requesting a more definite statement; and, on May 6, 2008, Wilson filed an amended complaint.  
25 On June 9, 2008, the Police Department filed a motion to dismiss, which Wilson opposed. The  
26 Board denied the same.

27 The City of North Las Vegas and the North Las Vegas Police Department have filed  
28 litigation against Wilson and this Board in an Eighth Judicial District Court case; and

1 contemporaneously therewith, North Las Vegas filed a motion to stay in this administrative  
2 action. Based upon the arguments raised in the motion,

3 IT IS HEREBY ORDERED that the motion is GRANTED and this matter is stayed  
4 pending a ruling from the Eighth Judicial District Court in Case No. A567116, which matter is  
5 currently scheduled for oral arguments on September 23, 2008.
