14 This matter came on before the State of Nevada, Local Government Employee-
15 Management Relations Board ("Board"), on September 16, 2010 for consideration and decision
16 pursuant to the provisions of the Local Government Employee-Management Relations Act ("the
17 Act"); NAC Chapter 288, NRS Chapter 233B, and was properly noticed pursuant to Nevada's
18 open meeting laws.

19 On September 9, 2010, Complainant Nicole Wilson filed a Petition for Rehearing
20 following the Board's entry of a final order. Ms. Wilson asks that the Board grant her petition
21 and consider amending our previous order to include an award of back pay and benefits in her
22 favor.

23 NRS 288.110(2) permits the Board to "restore to the party aggrieved any benefit of which
24 the party has been deprived." Our previous order is proper under this section, and an award of

1 back pay in this case is not appropriate. See Nevada Serv. Empl. Union, Local 1107 v. Orr, 121
2 Nev. 675, 119 P.3d 1259 (2005).

4 Petition for Rehearing and/or Motion to Alter and Amend is Denied.
