15 On the 12th day of January, 2011, this matter came on before the State of Nevada, Local
16 Government Employee-Management Relations Board ("Board"), for consideration and decision
17 pursuant to the provisions of NRS and NAC chapters 288, NRS chapter 233B, and was properly
18 noticed pursuant to Nevada's open meeting laws.

19 On December 13, 2010 Complainants filed a notice of withdrawal of the prohibited
20 practices complaint and requested that this Board dismiss the complaint against the City of North
21 Las Vegas.

22 The Board, having duly considered the pleadings filed herein, and having fully
23 considered the law and being fully advised in the premises makes its Findings of Fact,
24 Conclusions of Law and Order as follows:

FINDINGS OF FACT

- 25 1. Complainants North Las Vegas Police Officers Association and Terrence McAllister
26 have voluntarily withdrawn their complaint and requested that the Board dismiss this
27 matter.

- 1 2. No answer or other pleading has been filed with the Board by Respondent City of North
2 Las Vegas.
3 3. If any of the foregoing findings is more appropriately construed a conclusion of law, it
4 may be so construed.

5 **CONCLUSIONS OF LAW**

- 6 1. The Board accepts the Notice of Dismissal of Plaintiffs' Prohibited Labor Practices
7 Complaint filed by Complainants on December 13, 2010.
8 2. If any of the foregoing conclusions is more appropriately construed a finding of fact, it
9 may be so construed.


10 **ORDER**


11 IT IS HEREBY ORDERED that the Board accepts the Notice of Dismissal filed by


