Complainant James Crom has filed a Petition for Rehearing following the Board's order dismissing his complaint based upon the six-month statute of limitations in NRS 288.110(4). Crom asserts that the Board's determination that the complaint was filed on January 18, 2011 is incorrect. Having reviewed Crom's petition and the exhibits attached to the petition, we grant the request for rehearing on the statute of limitations issues as raised in the petition.




