### 12. Report of the Deputy Attorney General

Deputy Attorney General Bordelove gave a status report on the cases on judicial review or at the Nevada Supreme Court.

### 13. Report of the Commissioner

- A. Setting of the assessment rate for local governments for fiscal year 2021. Commissioner Snyder went through a memorandum providing an overview of the agency's revenues, expenditures and reserves for the reserve related to local governments. He specifically mentioned that the amount of the reserves was well in excess of the suggested level. He also discussed that there are a number of financial unknowns, including potential budget changes due to the COVID-19 crisis. Thus, he recommended that the current assessment be lowered to \$3.00 per employee.
- B. Setting of the assessment rate for the State of Nevada for fiscal year 2021. Commissioner Snyder went through a memorandum providing an overview of the agency's revenues, expenditures and reserves for the reserve related to the State. He specifically mentioned that the amount of the reserves was well below the suggested level. He also discussed that there are a number of financial unknowns, including potential budget changes due to the COVID-19 crisis. Although the calculations show that the rate should be \$7.15 per employee, in order to build up the reserve level, he recommended that the current assessment be kept at \$6.00 per employee due to the financial constraints on the State at this time.

Upon motion, the Board approved the two recommendations as presented.
