Pursuant to NAC 288.271(3), the presiding officer was Board Member Cottino. The Panel deliberated on Respondent Clark County School District's Counterpetition for Declaratory Order, and upon motion, came to the following decision; namely that the Board finds the EMRA provides for mandatory subjects of bargaining and that NRS 388G.610 and NRS 288.150 can be interpreted to render a harmonious result without NRS 388G.610 infringing on mandatory subjects of bargaining.
