21 LLP, and the North Lyon County Fire Protection District (“District”), Daniel McCassie
22 (“McCassie”), Mike Callagy, Jr. (“Callagy”) and Harry Wheeler (“Wheeler”) (collectively
23 “Respondents”), by and through their attorneys of record, Nick D. Crosby, Esq. of the law firm
24 of Marquis Aurbach Chtd., hereby file this Joint Status Report pursuant to the Board’s November
25 13, 2023 Order.

26 Complainants filed their Complaint with the Board on or about September 6, 2023.

1 September 26, 2023 and their Answer on October 17, 2023. On November 13, 2023, the Board
2 issued an Order granting the Motion to Stay the proceedings pending the outcome of the
3 grievance related to the matter and denied the Motion to Dismiss as moot.

4 On February 8, 2023, the parties appeared before Arbitrator Andrea Dooley to present
5 evidence regarding the underlying grievance. The matter has been submitted to Arbitrator
6 Dooley and, as of the date of this Joint Status Report, Arbitrator Dooley has not issued her
7 decision on the grievance.
