Having received notification that the CHURCHILL COUNTY SCHOOL DISTRICT has notified its classified employees that it has withdrawn its recognition of the NEVADA CLASSIFIED SCHOOL EMPLOYEES' ASSOCIATION, CHAPTER 5, (N.C.S.E.A.), and the Board having determined that such a withdrawal of recognition from an employee organization is a violation of NRS 288.160(3)(d), it is hereby

ORDERED that the CHURCHILL COUNTY SCHOOL DISTRICT shall immediately notify its classified employees, individually, and their employee organization, N.C.S.E.A., that said decertification is not effective and cannot be implemented without the approval of the Employee-Management Relations Board; and it is

FURTHER ORDERED that the CHURCHILE COUNTY SCHOOL DISTRICT must file a Petition for Declaratory Ruling on an expedited basis by February 17, 1984, and that Respondent Association will have until March 16, 1984, in which to respond.

Upon receipt of all documents, a hearing will be set by the Board for argumentation in Las Vegas, Nevada.
