17	At a regularly held public meeting, duly noticed and posted,
18	on June 28, 1988, at the hour of 7 PM, at the Bradley Building,
19	2501 E. Sahara Avenue, Las Vegas, Nevada, deliberations were held
20	in the above-entitled matter which was filed by the Clark County
21	Classroom Teachers Association on March 11, 1988. This order is
22	based upon the papers and pleadings of the parties.
23	The Complaint filed by the Clark County Classroom Teachers
24	Association alleged a violation of NRS 288.170, challenging the
25	Clark County School District's determination of the composition
26	of its bargaining unit for its administrative employees.
27	In determining whether or not to hear the case, the Board
28	finds that the Complaint fails to allege facts in violation of

NRS 288.170(2) and, therefore, fails to state a claim. Further\_ 1 assuming for purposes of argument that a claim was stated by the 2 Complaint, the action complained of occurred more than six (6) 3 months before the filing of the Complaint -- in this action, over 4 nineteen (19) years before the filing.
