23 **On October 30, 2000, Complainants LAS VEGAS CITY EMPLOYEES PROTECTIVE**
24 **AND BENEFIT ASSOCIATION aka LAS VEGAS CITY EMPLOYEES ASSOCIATION, a**
25 **Nevada Corporation, and DIANNA REED, as named plaintiff for Nevada Business Service (hereafter**
26 **"NBS") Employees, filed a Complaint with the Local Government Employee-Management Relations**
27 **Board (hereafter "Board").**

28 **On January 26, 2001, Respondent CITY OF LAS VEGAS filed a Motion to Dismiss, alleging**
among other things that it was not a party to the collective bargaining agreement and that alter ego
is an inappropriate theory against it. Complainants filed their opposition on February 21, 2001.

On January 30, 2001, Complainants filed a Motion for Leave to file an amended complaint
to better plead its case. On February 9, 2001, the City of Las Vegas opposed the same.

1 The Board deliberated on the motions on March 6, 2001, noticed in accordance with
2 Nevada's Open Meeting Law. Based upon the documents filed to date in this matter, and good cause
3 appearing therefore,

4 IT IS HEREBY ORDERED that the Motion to Dismiss is DENIED.

5 IT IS FURTHER ORDERED that the Motion for Leave to Amend Complaint is granted. The
6 amended complaint shall be served and filed within ten (10) days from this order.
