17 On January 29, 2002, Petitioner INTERNATIONAL BROTHERHOOD OF  
18 TEAMSTERS, LOCAL 14, AFL-CIO (hereafter "Teamsters") filed an Application for Order  
19 Convening an Administrative Hearing for the Purpose of Determining Whether to Conduct an  
20 Election Pursuant to NRS 288.160, NAC 288.145 and NAC 288.146(1) and (2) with the Local  
21 Government Employee-Management Relations Board (hereafter "Board").

22 On July 8, 2002, Respondent EDUCATION SUPPORT EMPLOYEES ASSOCIATION  
23 (hereafter "ESEA") filed a Motion for a Bifurcated Hearing. On July 11, 2002, Respondent  
24 CLARK COUNTY SCHOOL DISTRICT (hereafter "District") filed a joinder to said motion.

25 The Board deliberated on the motion on July 23, 2002, noticed in accordance with  
26 Nevada's Open Meeting Law. Based upon the Board's deliberations,

1 IT IS HEREBY ORDERED that the Motion for a Bifurcated Hearing is granted, and the  
2 matter will be scheduled for one day, with Local 14 having four hours in which to make its case,  
3 the Association having two hours to refute the same, and the School District having two hours to  
4 argue its position. Inasmuch as the Motion was unopposed, IT IS FURTHER ORDERED that  
5 the first hearing will pertain to whether Local 14's recognition request is defective and this is set  
6 for hearing on September 18, 2002. If the request is not defective, the remaining issues will be  
7 heard on September 19 and 20, 2002.
