On the 7th day of February, 2012, this matter came on before the State of Nevada, Local Government Employee-Management Relations Board ("Board"), for consideration and decision pursuant to the provisions of NRS and NAC chapters 288, NRS chapter 233B, and was properly noticed pursuant to Nevada's open meeting laws.

On January 13, 2012 this Board gave the parties to this proceeding 20 days to submit an agreed-upon alternative to conducting the run-off election as contemplated by the Nevada

1 Supreme Court order of December 21, 2009. The parties have not provided an agreed-upon
2 alternative election plan as requested by the Board.

3 Having considered the above, it is hereby ordered that International Brotherhood of
4 Teamsters Local No. 14's motion to approve the election plan is denied, the proposed election
5 plan not being an agreed-upon plan. See Nevada Supreme Court Order dated December 21,
6 2009.

7 It is further ordered that the Commissioner of the EMRB shall prepare an updated version
8 of the election plan previously utilized in this matter to conduct the election, and shall present the
9 plan to the Board at a future Board meeting for review and approval.
