16 On May 5, 2003, Complainant STEVEN B. KILGORE (hereinafter "Kilgore") filed a
17 complaint with the LOCAL GOVERNMENT EMPLOYEE-MANAGEMENT RELATIONS
18 BOARD (hereinafter "Board") and filed an amended complaint on August 7, 2003.

19 Respondent CITY OF HENDERSON (hereafter "City") filed a motion to strike the
20 amended complaint on August 20, 2003. Kilgore filed an opposition on September 2, 2003 and
21 Respondent HENDERSON POLICE OFFICER'S ASSOCIATION (hereafter "Association")
22 filed a motion to dismiss or strike the amended complaint and joinder in the City's motion on
23 September 8, 2003. The City filed their reply to the opposition on September 10, 2003.

24 The Board deliberated on the City's motion on September 11, 2003, noticed in
25 accordance with Nevada's Open Meeting Law. Based upon the deliberations,

5 288.235.


6 IT IS FURTHER ORDERED that the Complainant has leave of this Board to have filed
