16 On May 5, 2003, Petitioner Steven B. Kilgore (hereafter "Kilgore") filed a complaint
17 with the Local Government Employee-Management Relations Board. An amended complaint
18 was filed on August 7, 2003. The City of Henderson and the Henderson Police Department
19 (hereafter "City") filed their answer on September 25, 2003; and the Henderson Police Officers
20 Association (hereafter "HPOA") filed its answer on September 25, 2003. This matter was
21 scheduled to commence its hearing on December 9 and 10, 2003.

22 The Board deliberated on this matter on December 9, 2003, noticed in accordance with
23 Nevada's Open Meeting Law; and based upon such deliberations,

24 BASED on the stipulation of Kilgore and HPOA, through their respective counsel, IT IS
25 HEREBY ORDERED that the HPOA shall be dismissed from these proceedings, with prejudice,
26 upon the filing of a stipulation entered into by Kilgore and HPOA.

27 IT IS FURTHER ORDERED that this matter is deferred to arbitration. During this
28 deferral, the City has agreed not to further challenge the "status quo ante" order previously
entered by this Board and now on appeal before the Nevada Supreme Court. The City has

1 agreed that it will continue Kilgore on administrative leave with pay and benefits pursuant to that
2 "status quo ante" order until the arbitration has been completed and the proceedings before this
3 Board has concluded.

4 IT IS ORDERED that Kilgore shall provide status reports to this Board every thirty (30)
5 days.
