On October 28, 2003, Complainant JUDITH CARPENTER filed a complaint with the LOCAL GOVERNMENT EMPLOYEE-MANAGEMENT RELATIONS BOARD (hereinafter "Board").

On November 17, 2003, Respondents ROSEMARY VASSILIADIS, DEPUTY DIRECTOR OF AVIATION; DORIS DIAZ, TERMINAL 2 MANAGER; BILL KLEIN ASSISTANT DIRECOTR/AIRSIDE OPS; CHRISTINE SANTIAGO, MANAGER, AIRPORT EMPLOYEE SERVICES; KATHLEEN KIRWAN, MANAGEMENT ANALYST, HR, filed a Motion to Dismiss Complaint or, in the alternative, Motion for More Definite Statement and Motion to Dismiss Intervener and Request for Attorney's Fees and Expenses.

1 On November 25, 2003, Complainant filed a Motion to Strike Fugitive Document and  
2 Entry of Judgement. On December 25, 2003, Respondents filed a Reply to Complainant's  
3 Opposition and an Opposition to Petition for Intervention.

4 On December 8, 2003, Complainant filed a Board Information Brief; Supplemental  
5 Points and Authorities and on December 15, 2003, filed a Response to Respondent Motion to  
6 Dismiss Intervener.

7 On December 17, 2003, Complainant filed a Response to Respondents' Request for a  
8 More Definite Statement and Reply to Motion for Default and Reply to Request for Attorney  
9 Fees and Expenses. On December 24, 2003, Respondents' filed a Motion to Strike  
10 Complainant's Response with Complainant filing a Response on December 29, 2003.

11 The Board deliberated on said pleadings on January 7, 2004, noticed in accordance with  
12 Nevada's Open Meeting Law. Based upon their deliberations,

13 IT IS HEREBY ORDERED that Respondents' Motion to Dismiss is denied, without  
14 prejudice, in part and granted in part. It is incumbent upon the Complainant to file an Amended  
15 Complaint within twenty (20) days of the date of this order that complies with NAC 288.200;  
16 inter alia, contains a "clear and concise statement of the facts constituting the alleged practice  
17 sufficient to raise a justiciable controversy under Chapter 288 of NRS, including the time and  
18 place of the occurrence of the particular acts and the names of persons involved" (emphasis  
19 added); verify the Complaint; and pursuant to NAC 288.231, "not exceed 30 pages."

20 IT IS FURTHER ORDERED that Complainant confine her Complaint to this Board to  
21 the area of law within its jurisdiction. This Board does not have jurisdiction over the  
22 constitutional issues raised by complainant, nor NRS Chapter 613, nor tort claims.

23 IT IS FURTHER ORDERED that should Louis Chachere wish to intervene in this action  
24 that he comply with NAC 288.260. In the alternative, it is incumbent upon the Complainant to  
25 comply with NAC 288.278 concerning representation.
