22 On October 28, 2003, Judith L. Carpenter (hereafter "Carpenter") filed a complaint with  
23 the Local Government Employee-Management Relations Board (hereafter "Board") ag st  
24 Rosemary Vassiliadis, Doris Diaz, Bill Klein, Christine Santiago, and Kathleen Kirwan  
25 (hereafter collectively "Supervisors"). On January 7, 2004, the Board ordered Carpenter to file a  
26 more specific amended complaint. That Amended Complaint was filed on February 2, 2004.  
27 The Supervisors' Answer was filed on February 4, 2004.

28 Various other "documents" were filed by Carpenter, including but not limited to, Request  
for Summary or Declaratory Judgment, Board Information Brief III, Request for Official Notice  
of Exceptions, Request for Injunctive Relief, and Board Information Brief II, A Fire Free Zone  
of Adversarial Information.

1 The Board held deliberations on February 17, 2004 on the afore-mentioned "documents,"  
2 noticed in accordance with Nevada's Open Meeting Law; and based thereon:

3 IT IS HEREBY ORDERED that Carpenter's Request for Injunctive Relief is denied, as  
4 there has been no showing of irreparable harm and likelihood of success on the merits.

5 IT IS FURTHER ORDERED that Carpenter's request for Summary or Declaratory  
6 Judgment is denied.

7 IT IS FURTHER ORDERED that Carpenter shall file a First Amended Complaint within  
8 ten (10) days of this order due to her failure to comply with NAC Chapter 288, and more  
9 specifically, NAC 288.200 and NAC 288.231. Furthermore, such pleading shall be double-  
10 spaced. All parties are required to comply with NRS Chapter 288 and NAC Chapter 288  
11 whether they are pro se litigants or licensed attorneys. Fugitive documents, such as  
12 Informational Briefs, were not requested by this Board and no references to such "documents"  
13 can be identified in NRS Chapter 288 or NAC Chapter 288. Such fugitive documents may not  
14 be considered by this Board, especially if the filing of such documents is an attempt to  
15 circumvent the 30-page limitation.
