
The Board held deliberations on said motions on August 22, 2006, noticed in accordance with Nevada's Open Meeting Law. Based upon the Board's deliberations,


IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Petitioner's Motion for Expedited Review and Hearing is GRANTED.
