23 The matter came on for discussion and deliberations by the Local Government  
24 Employee-Management Relations Board ("Board") on July 12-13, 2007, noticed pursuant to

6 the filing of the complaint with this Board; and (2) When Rhodes and Thomas first contacted  
7 Suttle and/or Mireles. Such information shall be provided to the Board within twenty (20) days  
8 after service of this order.
