On October 24, 2006, a complaint alleging prohibited labor practices was filed by Judith Carpenter ("Carpenter"), against the Respondents above-named, with the Local Government Employee-Management Relations Board ("Board"). The Certificate of Mailing on the Complaint indicated that the Complaint was mailed, but does not indicate that it was mailed by certified mail, return receipt requested. On January 3, 2007, Carpenter filed a Motion to Default the Respondents as an Answer had not been timely filed. Respondents alleged they did not receive the Complaint. Respondents filed an Opposition to the Motion, and thereafter, Carpenter filed a document entitled "Vexatious Litigation: Respondents' Latest Weapon for Constructive Discharge."

2 pursuant to the provisions of NRS and NAC Chapters 288, as well as NRS Chapter 233B^{and}
3 Nevada's Open Meeting laws.
