16 On September 20, 2007, this matter came on for discussion and deliberations by the  
17 Local Government Employee-Management Relations Board ("Board"), noticed pursuant to NRS  
18 and NAC chapters 288, NRS chapter 233B, and Nevada's open meeting laws; and the Board  
19 finds, concludes, and orders as follows:


20 On March 30, 2007, Ronald G. Taylor ("Taylor") filed a complaint with the Local  
21 Government Employee-Management Relations Board ("Board") against the Clark County  
22 School District ("School District") and the Clark County Education Association ("CCEA").

23 On July 12, 2007, Taylor filed a "Motion to Withdraw" this case against all named  
24 Respondents without prejudice. CCEA filed a "Response" to the Motion on July 30, 2007. On  
25 August 24, 2007, Taylor and CCEA filed a joint "Stipulation to Dismiss Complaint and  
26 Counterclaim" with prejudice. The School District did not sign this Stipulation; however, it  
27 appears that the intent of the parties is to dismiss this matter in its entirety, with each party to  
bear their own costs incurred.

1 Based thereupon, IT IS HEREBY ORDERED that the Board grants Taylor's motion  
2 withdraw as to the School District, and the complaint against the School District is hereby  
3 dismissed without prejudice. IT IS FURTHER ORDERED, pursuant to Taylor's stipulation with  
4 the Association, that the complaint and counterclaim are dismissed with prejudice with each  
5 party to bear their own fees and costs.
