14 On the 16th day of July, 2008, this matter came on before the State of Nevada, Local
15 Government Employee-Management Relations Board ("Board"), for consideration and decision
16 pursuant to the provisions of NRS and NAC chapters 288, NRS chapter 233B, and Nevada's
17 open meeting laws.

18 On November 30, 2007, the International Association of Fire Fighters, Local 731
19 ("Association") filed a complaint with the Board, alleging prohibited labor practices by the City
20 of Reno ("Reno"). On December 24, 2007, Reno filed its answer; and thereafter, both parties
21 filed their respective pre-hearing statements. This matter was noticed for hearing on May 9,
22 2008, scheduling the hearing for August 18 and 19, 2008. Thereafter, the Association filed a
23 motion to vacate the hearing and requested that this matter be deferred pending an arbitration by
24 the parties pursuant to their collective bargaining agreement.

25 BASED UPON the above, IT IS HEREBY ORDERED that this matter is deferred
26 pending the parties exhausting their collectively bargained rights. The parties shall provide a
27 status report to this Board every three months, commencing three (3) months from the service of


1 this order and continuing thereafter until the arbitration has concluded. Once the arbitration is
2 concluded, the parties shall so notify this Board.


