14 On the 13th day of March, 2013, this matter came on before the State of Nevada, Local
15 Government Employee-Management Relations Board ("Board"), for consideration and decision
16 pursuant to the provisions of NRS and NAC chapters 288, NRS chapter 233B, and was properly
17 noticed pursuant to Nevada's open meeting laws.

18 On February 22, 2013 Complainant International Association of Firefighters, Local 731
19 and Respondent City Reno jointly filed stipulation to dismiss the prohibited practices complaint
20 and requested that this Board dismiss the complaint with prejudice, each party to bear its own
21 fees and costs.

22 The Board, having duly considered the pleadings filed herein, and having fully
23 considered the law and being fully advised in the premises makes its Findings of Fact,
24 Conclusions of Law and Order as follows:

1 **FINDINGS OF FACT**

- 2 1. Complainant International Association of Firefighters, Local 731 and Respondent
3 City Reno have stipulated to dismiss this matter.
4 2. If any of the foregoing findings is more appropriately construed a conclusion of law,
5 it may be so construed.

7 **CONCLUSIONS OF LAW**

- 8 1. NAC 288.375(1) states that the Board may dismiss a matter if the complaint has been
9 settled and notice of settlement has been received by the Board.
10 2. The stipulation jointly filed by the parties complies with the provisions of NAC
11 288.375(1), and the Board accepts the same.
12 3. If any of the foregoing conclusions is more appropriately construed a finding of fact,
13 it may be so construed.

15 **ORDER**

16 **IT IS HEREBY ORDERED** that this action is dismissed with prejudice, each
17 party to bear its own fees and costs.
