14 This matter came on before the State of Nevada, Local Government Employee-
15 Management Relations Board ("Board"), on October 19, 2010 for consideration and decision
16 pursuant to the provisions of the Local Government Employee-Management Relations Act ("the
17 Act"); NAC Chapter 288, NRS Chapter 233B, and was properly noticed pursuant to Nevada's
18 open meeting laws.

19 On August 26, 2010, the Board entered an order finding that Respondent City of North
20 Las Vegas had committed a prohibited labor practice against Complainant Nicole Wilson in
21 violation of NRS 288.270(1)(d). Pursuant to NRS 288.110(6) Ms. Wilson asks that she be
22 awarded her costs and attorney's fees as the prevailing party in this action. The City has opposed
23 the request.

24 Having considered the arguments and evidence presented by Complainant and
25 Respondent,

26 IT IS HEREBY ORDERED that Nicole Wilson is awarded the sum of \$9,062.99 for her
27 costs incurred in this action. The Board has reviewed the exhibits presented by Ms. Wilson and
28 evidence of her costs and finds the claimed amount of costs to be reasonable. The Board does

1 not find that an award of attorney's fees is appropriate in this case because Ms. Wilson appear ed
2 before the Board in a pro se capacity. This award is made pursuant to the Board's authority und er
3 NRS 288.110(6),
