16 On the 18th day of November, 2008, this matter came on before the State of Nevada  
17 Local Government Employee-Management Relations Board ("Board") for deliberations and  
18 discussions. The matter was duly noticed pursuant to NRS and NAC chapters 288, NRS chapter  
19 233B, and Nevada's Open Meeting laws.

20 The complaint in this matter was filed with the Board by Timothy Frabbiele on March 11  
21 2008, complaining of alleged prohibited labor practices by North Las Vegas and the North Las  
22 Vegas Police Department (collectively, the "Police Department") and the North Las Vegas  
23 Police Officers Association ("Association"). Rather than file answers, both the Police  
24 Department and the Association filed motions for dismissal. Frabbiele opposed both motions.  
25 Thereafter, the Association filed a "Motion to Convert Motion to Dismiss to a Motion for  
26 Summary Judgment." Frabbiele did not file an opposition to that motion. The motions were  
27 denied without prejudice. Thereafter, the Association filed its prehearing statement.


1 Both the Police Department and Frabbiele filed motions to stay this matter pending the outcome  
2 of a District Court case. The Association filed an answer with a cross-claim against the Police  
3 Department; and the Police Department has filed a motion to dismiss that cross-claim.


4 The District Court has rendered a decision in the action filed by the Police Department  
5 against Frabbiele and others, finding in favor of the local government employees and against the  
6 Police Department. An appeal has not yet been taken by any of the parties to the action.


7 IT IS THEREFORE ORDERED that Frabbiele and the City of North Las Vegas/the  
8 North Las Vegas Police Department shall file their prehearing statements within twenty (20)  
9 days after written notice of the entry of this order. Failure to do so, in compliance with this  
10 Order, may result in sanctions.
