14 On the 7th day of February, 2012, this matter came on before the State of Nevada, Local
15 Government Employee-Management Relations Board ("Board"), for consideration and decision
16 pursuant to the provisions of NRS and NAC chapters 288, NRS chapter 233B, and was properly
17 noticed pursuant to Nevada's open meeting laws.

18 The Board has reviewed Complainant's Status Report indicating that arbitration has been
19 completed and that the arbitrator has made an award in favor of Complainant Rosenberg.
20 Pursuant to City of Reno v. Reno Police Protective Ass'n, 118 Nev. 889, 59 P.3d 1212 (2002),
21 this Board must apply the limited-deferral doctrine to an arbitrator's decision.

22 It is the intention of this Board to adhere to the limited-deferral doctrine as outlined in
23 City of Reno. Therefore, it is hereby ordered that any party who desires this Board to proceed
24 with a hearing on the prohibited labor practices complaint rather than defer to the arbitrator's
25 award shall have 30 days from the date of this order to present Points and Authorities to the


