On the 17th day of February, 2010, this matter came on before the State of Nevada, Local Government Employee-Management Relations Board ("Board"), for consideration and decision pursuant to the provisions of NRS and NAC chapters 288, NRS chapter 233B, and was properly noticed pursuant to Nevada's open meeting laws.

Complainant Jerry Mann has filed a motion for leave to file an amended complaint, which was opposed by Respondents Clark County Education Association and Nevada State Education Association (the "Association").

NAC 288.235(1) states that the Board "may allow any pleading or motion to be amended or corrected, or any omission in the pleading, motion or papers to be cured."

1 Mann has submitted a proposed amended complaint which includes claims against the  
2 Clark County School District and a claim for relief that the Association did not timely request  
3 arbitration. The Board has since dismissed these claims in separate orders.

4 Based upon the foregoing, and good cause appearing therefore:

5 It is hereby ordered that Complainant's motion for leave to file an amended pleading is  
6 Granted. Complainant may file an amended complaint that is in compliance with the Board's  
7 previous orders granting the Clark County School District's motion to dismiss and granting in  
8 part and denying in part the Associations motion to dismiss;

9 It is further ordered that Respondent may file an answer to Mann's amended complaint  
10 within 20 days after being served with the amended complaint, and that the parties shall submit  
11 pre-hearing statements no later than 20 days from the date that Respondent's answer is due.


