22 **FINDINGS OF FACT**

- 23 1. Complainant Clark County Association of School Administrators and Professional-
24 Technical Employees ("Association") has voluntarily withdrawn its complaint and
25 requested that the Board dismiss this matter. Respondent Clark County School
26 District Board of Trustees consents to the withdrawal of the complaint.

28 2. If any of the foregoing findings is more appropriately construed a conclusion of law,
it may be so construed.
