14 On the 14th day of April, 2011, this matter came on before the State of Nevada, Local
15 Government Employee-Management Relations Board ("Board"), for consideration and decision
16 pursuant to the provisions of NRS and NAC chapters 288, NRS chapter 233B, and was properly
17 noticed pursuant to Nevada's open meeting laws.

18 Having reviewed the pleadings filed in this matter, the Board finds as follows:

- 19 1. NAC 288.250 requires all parties, including complainants, to file a pre-hearing statement
20 within 20 days after service of the Answer.
- 21 2. Respondent Las Vegas City Employee's Association filed and served its Answer on
22 January 20, 2011 and Respondent City of Las Vegas filed and served its Answer on
23 January 31, 2011.
- 24 3. Complainant has not yet filed a pre-hearing statement as required by NAC 288.250.
- 25 4. Pursuant to NAC 288.375(3), the Board may dismiss a complaint if the complainant,
26 within a reasonable time, fails to prosecute its complaint.
- 27 5. Complainant has had a reasonable amount of time to file a pre-hearing statement in this
28 matter.

1 Based upon the foregoing, and good cause appearing therefore,

2 It is hereby ordered that Complainant shall file a pre-hearing statement no later than 10
3 days after receiving notice of entry of this order.

4 It is further ordered that in the event that Complainant does not file a pre-hearing
5 statement within the 10 days specified herein, this matter shall be dismissed.
